The name of the Journal renders its scope. Thus, it basically covers various fields of international law, both public and private, and the European Union law. On account of the practical importance of the latter we make it, beside international law, the leading topic of the Journal. But it does not exclude contributions dedicated to non-European regional international law, international organizations law, so called self-contained regimes law, and even legal problems lying on the borderline between international law and states' legal orders. We are aware of the interdependency of various levels of legal regulations in today's world, which points out the flexibility of borders of internationality of contemporary law.
