INFORMATION CLAUSE FOR PARTICIPANTS OF SEeB NATURE PHOTOGRAPHY COMPETITION "FOUR SEASONS"

According to Art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of European Union27 April 2016 on the protection of natural persons concerning the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ EU L 119 of 04/05/2016), hereinafter referred to as GDPR, Cardinal Stefan Wyszynski University in Warsaw informs that:

1. The Administrator of your personal data is the Cardinal Stefan Wyszynski University in Warsaw (UKSW), Dewajtis 5, 01-815 Warsaw, Poland.

2. The Administrator has appointed the Data Protection Officer at UKSW, whom you can contact in matters relating to the processing of your personal data by the Administrator, including the rights you are entitled to. Contact: <u>iod@uksw.edu.pl</u>, tel.: +48 22 / 5619034.

3. The purpose of the processing of your personal data is to organize the SEeB Nature Photography Competition "Four Seasons," hereinafter referred to as the "Competition." The unit processing personal data is the Editorial Team of the academic journal "Studia Ecologiae et Bioethicae" (SEeB) (ISSN: 1733-1218; www.seib.uksw.edu.pl) in cooperation with the UKSW Academic Publishing House and the Office of Communication and Promotion of the Cardinal Stefan Wyszynski University in Warsaw.

4. The legal basis for processing your personal data collected for participating in the competition is art. 6, section 1, letter a) GDPR.

5. Your consent to the processing of your personal data provided in the form, i.e., name, surname, contact details: telephone number, address, email, is voluntary, but your refusal to grant it results in your inability to participate in the competition.

6. Your personal data will be processed regarding the organization of the competition, preparation of the list of participants, selection of the finalists, and publication of the competition results.

7. The Administrator will process your personal data in the period of time necessary to carry out the competition, but no longer than 30 days from its end or until you submit an effective objection to the processing of your personal data. The period of the processing of your personal data may be extended within the limits of the law if the processing of your personal data is necessary to secure accounting documentation in connection with the awarding of prizes and to pursue or clarify claims. After the processing period, your personal data will be permanently deleted. Anonymized data may be archived only for statistical purposes.

8. Only employees authorized by the Administrator have access to your personal data within the University's organizational structure, to the extent necessary.

9. Your personal data will not be disclosed to other entities except for its disclosure to entities authorized by law and based on concluded contracts.

10. The organizational unit processing your personal data in the scope of considering applications for information regarding the method and scope of processing your personal data in connection with participation in the competition is the Editorial Office of the journal "Studia Ecologiae et Bioethicae" (SEeB) established for the Administrator, contact: email address: <u>seib@uksw.edu.pl</u>

11. You have the following rights:

1) the right to withdraw your consent to data processing,

2) the right to access your personal data,

3) the right to request rectification of your personal data,

4) the right to request the deletion of your personal data when there is no legal basis for their processing,

5) the right to complain to the supervisory authority responsible for protecting personal data, i.e., the President of the Personal Data Protection Office in Poland.

12. To the extent that your personal data is processed based on your consent, you have the right to withdraw your consent to data processing at any time.
